This Product offers the Investor at the Redemption Date a Cash Settlement in the Settlement Currency equal to the Denomination multiplied by the Bonus Level (in %), unless a Barrier Event has occurred. In addition, the Investor has the opportunity to participate in the performance of the Underlying with the Worst Performance between the Bonus Level (in %) and the Cap Level (in %), leveraged by the Participation . If a Barrier Event has occurred, the redemption of the Product will depend on the value of the Underlying with the Worst Performance, as described in section "Redemption".
