Product Description

This Product offers the Investor on the Redemption Date the possibility to participate in a positive performance of the Underlying up to the Cap Level. In addition, the Investor will always receive an amount equal to the Denomination as long as the Underlying closes above the Strike Level on the Final Fixing Date. If, however, the Underlying closes at or below the Strike Level, the redemption of the Product will depend on the value of the Underlying, as described in section "Redemption". Due to the buffer feature (Strike Level below Initial Fixing Level) the possible loss of this Product will always be smaller than with a direct investment.
