If a Knock-Out Event, as defined below, has occurred, the Product expires worthless immediately. The Put Warrant with Knock-Out Open End does not have a fixed maturity (open end), but may be exercised by the Investor or terminated by the Issuer. The Current Knock-Out Barrier is always equal to the Current Strike.

Such selling restrictions should not be taken as definitive guidance as to whether the Products may be offered, sold or advertised in any jurisdiction.
